I want to extend my appreciation for your support and belief in the mission of The Community Foundation – to philanthropically address the needs of McHenry County by providing leadership, granting resources, stewarding assets, and fostering awareness.

Enclosed, please find your fund statements for Q4 of FY23 (July 1, 2023 – September 30, 2023), the year-end statement for FY23 (October 1, 2022 – September 30, 2023), and the Q1 statement for FY24. The market encountered fluctuations throughout 2023, however, we are pleased that the market finished up for the year, which will help The Foundation’s ability to infuse much needed resources back into the community. I apologize for the delay in getting these statements to you, and I appreciate your patience as we work to create a more complete system for sending out quarterly fund statements – ultimately trying to improve our communications with our fund holders and partners.

As the steward of your funds, it’s important that we annually communicate the amount available for distribution. The spendable, or distributable amount, is calculated on an annual basis and is based upon the CFMC’s spending policy, which is 4% applied to the average daily balance of the previous 12 quarters’ value of the fund. All endowed funds are subject to CFMC’s spending policy. As a reminder, there will never be a spendable amount listed on a non-endowed fund as all of the funds can be dispersed.

The available distribution for your Endowed Agency Fund is listed below. The spendable balances that are shown reflect both FY22 and FY23 balances, which is why the amounts may appear to be higher than they have been in the past. Please take some time and thoughtfully consider whether you will be making a distribution from your funds this year.
